Buddy's will not sell, disseminate, disclose, trade, transmit, transfer, share, lease or rent any personally identifiable information to any third party not specifically authorized by you to receive your information except as we have disclosed to you in this Privacy Policy.

When you visit Buddy's, we may collect information from you. This information includes but is not limited to: IP Address, your Operating System, pages visited, total time spent on website or specific pages, links that are clicked, and your browser type and version.

## 2. Use and Sharing of Data Collected

Buddy's may disclose information we collect to non-affiliated third parties that are acting on our behalf, or as permitted or required by law. The information that is collected, used and shared is limited to purposes that intend to improve your experience with Buddy's.

Buddy's may use and share information as described below:

To inform customers of Buddy's statistic on visitors and users;

Product and software development;

For editorial and feedback purposes;

To analyze user site usage;

To send alerts specific to Buddy's;

To deliver to you any administrative notices relating to the use of Buddy's;

In response to subpoenas and other legal processes;

For marketing and promotional purposes;

To enforce Buddy's's Terms of Use; and

As otherwise stated in the Privacy Policy.

Buddy's's privacy policy does not apply to services or products offered by any third party. If you decide to request services or products from such companies, you grant Buddy's permission to provide these third parties with personal information about you necessary to fulfill or process your request.

Users that provide their email address may occasionally receive emails from Buddy's. Users have the option to opt-out of receiving emails from Buddy's at any time by emailing [easyvpay@buddyrents.com](mailto:easyvpay@buddyrents.com). If a user has subscribed to a service to receive notification should an additional reduced offer become available, opting out of emails will cancel the subscription and the notification of offer will not be sent. If user chooses to opt out, it is the user's decision alone; user cannot and will not hold Buddy's responsible for any consequences due to opting out of emails.

Buddy's may set and access cookies on your computer to track and store data you have entered while visiting [www.easyvpay.buddyrents.com](http://www.easyvpay.buddyrents.com). At Buddy's, a cookie is used to identify one unique visitor from another visitor. Our cookies are encoded so that only we can understand the data stored in them. All cookies expire and are deleted as soon as the user closes their browser.

Buddy's uses a number of security measures to protect the security and integrity of your data. Once any personal data comes into our possession, we will take reasonable steps to protect that information from misuse and loss and from unauthorized access, modification or disclosure.

We use encryption methods and authentication processes to maintain your security when you are using [www.easyvpay.buddyrents.com](http://www.easyvpay.buddyrents.com). Firewall barriers are also used to protect your account and information, from unauthorized access. Buddy's site is tested and monitored regularly to ensure all areas are protected from possible hacking. The Buddy's maintains servers in a secure location. Access to our servers requires several levels of authentication.

It is important to understand that while Buddy's takes the above precautions to safeguard your information at Buddy's, these precautions do not extend to any Third Party websites you may come across.
